Sewer Readiness to Serve (Unmetered) Charges

Flat Rate/Per Unit = \$27.43 (County) + \$11.66 (Township) = \$39.09

Sewer Readiness to Serve (Metered) Charges

Flat Rate/Per Unit = \$4.67 (County) + \$3.41 (Township) = \$8.08

Sewer Commodity Charges added to Sewer Readiness to Serve (Metered) Charges

\$1.82 (County) + \$0.66 (Township) = \$2.48 per 100 cubic feet

Sewer Monthly Fee Calculation Example for Metered per 400 cubic ft of water usage.

Readiness to Serve (RTS) Calculation

Water Commodity Charges added to Water Readiness to Serve Charges

$$\$5.75 \text{ (County)} + \$0.08 \text{ (Township)} = \$5.83 \text{ per 100 cubic feet}$$

Water Monthly Fee Calculation Example for 5/8 meter per 400 cubic ft of water usage.

$$4 \times \$5.83 = \$23.32 + \$24.75 = \$48.07$$

Commodity Charges (applies to both Individual and Master Meters)

A. The total commodity charge is \$5.75 per 100 cubic feet.

B. The commodity charge for individual customers who exceed 500,000 cubic feet per month will be \$5.75 per 100 cubic feet for the first 500,000 cubic feet and \$1.90 per 100 cubic feet for water above 500,000 cubic feet.
